Picasso, Van Gogh, Monet – even if alive, wouldn't be here around July 7. However, our own painting contractor will then be starting our own project -- painting half of our community. Thus, Bldgs. Persons residing in #A through #W will have received a letter from our HOA, detailing the painters' procedures and the residents' responsibilities. Take a few minutes to observe the professionalism of these contractors as they help us preserve our physical assets and, therefore, our property values.
